If your Trimble NetR5 receiver is supplied with other Trimble software, you will need to run the antenna and receiver configuration update program, which is on the *Trimble* Survey and Infrastructure Receivers CD. This program updates your software with the most current information for all supported receivers and antennas.

Before you upgrade the firmware, Trimble recommends that you download and back up any files that are on the receiver.

For more information about the *Trimble Survey and Infrastructure Receivers CD* distributed with this product, please refer to the Trimble NetR5 Receiver User Guide included on the CD.

For information about the CD distributed with other Trimble products, refer to the user guide or CD for that product.

Important features

The following features are new:

- Tracking of the L5 signal.
- Tracking of GLONASS L1/L2 signals.
- 72-channels available for signal tracking.
- Internal battery (capable of lasting up to 15 hours).
- New Zephyr Geodetic™ Model 2 antenna. A Dorne Margolin Choke ring can be used but it cannot track the L5 GPS or GLONASS signals.
- 64 MB of internal memory (59 MB usable for data logging).
- USB memory stick/USB hard drive support. For USB support, the external drive must be formatted using the FAT32 file system (NTFS is not supported). To format the drive, free utilities are available from the Internet, for example www.compuapps.com/download/swissknife/Swissknife.htm.

Trimble has tested and recommends the following drives:

- USB flash drives: SanDisk 256 MB, SanDisk Cruzer Mini 1 GB, AVB 256 MB, Netac 128 MB
- USB hard drives: Maxtor 300 GB, Western DigitaL 250 GB, Adaptec USB drive enclosure. These should work with all hard disks.

If you want to use another drive, it should be tested for compatibility first.

- The receiver is *not* compatible with Trimble Survey Controller [™] or Survey Pro [™]
- A front panel UI allows you to set up Ethernet configuration and base station parameters without the need for any additional hardware or software. For more information, refer to the NetR5 Quick Start Guide, which is included in the accessory kit.
- E-mail client The receiver can send e-mails (receiver requires access to an SMTP server) to report various information on status and errors
- FTP push Files can be automatically sent to an FTP server.
- TRIMMARK[™] 3 radio To transmit RTCM 3.0 corrections and/or CMR messages for RTK measurements that include GLONASS corrections, make sure that the TRIMMARK radio is using firmware 1.26 or later. TRIMMARK firmware is available from the Trimble website (www.trimble.com/trimmark3_ts.asp).

Note - The PDL450 and the HPB450 radios do not need firmware upgrades to be compatible.

To use three serial ports at once, you need an adaptor, which is not currently available. For more information, please contact your Trimble distributor.

Updating the system files

Before you can use your Trimble NetR5 receiver with Trimble office software, such as Trimble Geomatics Office, Trimble Total Control, or Terramodel[®], you must install or update the following files:

- The NetR5 receiver and GPSNet receiver device driver for data transfer
- Configuration files

These files provide the latest list of antennas and receivers that are recognized by Trimble software. They also ensure that antenna and receiver information flows correctly from the receiver to the office software.

To install or update these files:

- Run the *Trimble Survey and Infrastructure Receivers CD*.
- From the main menu, select *Install Components for TGO / TTC / Terramodel*.
- Follow the instructions in the installation wizard.

Note – You must also install the latest version of the software or firmware for any other Trimble product that you will use with the NetR5 receiver.

Updating the utilities

The *Trimble Survey and Infrastructure Receivers CD* contains the following utilities. Make sure that you install the latest versions of these utilities.

WinFlash utility

The WinFlash utility communicates with Trimble products, and enables them to perform functions that include:

- installing and updating receiver firmware
- upgrading receiver options
- retrieving receiver configuration
- configuring the Bluetooth ID string to help identify the receiver when it is connected using Bluetooth[®] wireless technology
- Configuring the Ethernet settings

Installing the WinFlash utility

The WinFlash utility provided with this release supports only the Trimble NetR5 receiver. To download the WinFlash utility for other receivers, such as the Trimble R7 and R8 GNSS, go to the Support section of the Trimble website (www.trimble.com/support.shtml).

If you have already run the *Install essential software* option from the *Trimble Survey and Infrastructure Receivers CD*, the WinFlash utility is installed on the computer.

Note – You can install the WinFlash utility on as many computers as required. The version of the WinFlash utility on the Trimble Survey and Infrastructure Receivers CD is fully compatible with other copies of the software that you may have for other Trimble products. Installing the WinFlash utility from this CD will not disrupt operation with other Trimble devices.

To install the WinFlash utility on another office computer, or to install reinstall it without installing other software:

- 1. Run the *Trimble Survey and Infrastructure Receivers CD*.
- 2. From the main menu, select *Install individual software packages*.
- 3. From the menu that appears, select *WinFlash vX.XX for Trimble Series Receivers*.
- 4. Follow the instructions in the installation wizard.

The Trimble Data Transfer utility

Use the Trimble Data Transfer utility to transfer data between a variety of data controllers and an office computer.

Installing the Data Transfer utility

If you have already run the *Install essential software* option from the *Trimble Survey and Infrastructure Receivers CD*, the Data Transfer utility is installed on the computer.

Note - You can install the Data Transfer utility on any number of computers.

To install the Data Transfer utility on another office computer, or to reinstall it without installing other software:

- 1. Run the CD.
- From the main menu, select *Install individual software packages*.
- 3. From the menu that appears, select *Data Transfer vX.XX*.
- 4. Follow the instructions supplied by the installation wizard.

Using the Data Transfer utility to connect to the receiver

Connect the Data Transfer utility to a GPS receiver (Trimble R/5000 Series) default device, or create a new GPS receiver (Trimble R/5000 Series) device definition. You cannot use a device definition for another type of receiver. For more information about creating a new device, refer to the Data Transfer Help.

Trimble recommends that you register your Trimble NetR5 GNSS Infrastructure receiver to protect your investment and to ensure that the system is always up to date. When you register the receiver, you will be notified by e-mail when there are updates to the receiver firmware, or when new functionality becomes available.

To register the receiver:

- Run the *Trimble Survey and Infrastructure Receivers CD*.
- From the main menu, select Register your receiver.
- 3. Do one of the following:
 - To register online, select *Register using the Internet*. The online registration form opens in your default web browser. Fill in the required fields, and then click **Submit** to submit the completed form.
 - To register by facsimile or mail, select Register using fax or mail. The registration form opens in the Microsoft® WordPad editor. Fill in the required fields, print the form and then fax or mail it to the address shown at the bottom of the form.
